## Dear Friends,

Thank you for inviting me to the Board meeting on Monday. It was good to see the familiar faces, and to meet the new ones.

I apologize if I was inappropriate stepping into an agenda discussion when I am not a member of the Board, but I felt a need to give a little history on the bulletin boards. Please know this: at the time I resigned in 2013, the Board was unaware of my thinking. The issue of inclusivity is personal to me, and I did not wish to impose my belief sets on the Board. I discussed it only with the Executive committee, which at the time was the President and Treasurer (I was Vice Prez). I am generally not a person who enjoys controversy.

When PIE publicizes anything, there is a tacit endorsement of the event, service or information in the posting. For that reason, I believe it is important that PIE is clear about what they promote.

As promised, here is some suggested wording for a policy.

"PIE's communication hub to the membership includes posting on the website and the PIE-sponsored community bulletin boards. PIE relays to its membership information about both PIE-related and non-PIE events, services and information. As a not-for-profit organization, PIE applies non-discriminatory best standards and practices. Therefore, all postings and notices will consist of events and services that are open and available to everyone in the local community, or news items and information that is of general interest to all. Other notices, including commercial postings (business cards, sales of goods or services) should be posted on alternate bulletin boards, such as the Islander-sponsored bulletin board."

Feel free to use any part or change and adapt the above. It's just some suggested language. Note that I extracted "free to attend" from the original wording. Many of PIE's events are fundraisers or involve an entry fee to non-members.

Please know that I would argue the same position if we were discussing a women's group. There are groups where gender separation may be important, such as men's or women's support groups. But I still believe the general rule for the PIE bulletin boards should be inclusivity, since there are alternative options for posting non-conforming notices.
