Comments from Guests

- Lindsay & John attended to discuss the proposed location of the Freedom Transit
 - The proposed location is at 100 Kettle Harbor which is a WCIND lot that they had been told would never be built on.
 - This would mean the traffic to the new ferry landing would go within 20' from Lindsay and John's house.
 - On North Gulf, the closest house is 670' from barge landing. On this ferry it would be 20'
 - This location is a blind corner, our shell roads are not meant for high volume commercial traffic.

- Zoned residential
 - BBI zoning doesn't allow commercial operations
- They are concerned that this is being done without input from the community and homeowners
- In Aug, Freedom Transit was on the WCIND agenda with a proposal to use this lot. In November there was a lease agreement for 50 years for this property. Lindsay and John attended and Bill Truex expressed that this wasn't a good idea for the location - as this is a residential area.
 - Lindsay & John later met with Bill Truex.
 - WCIND has also suggested an alternative location for the ferry landing off Yacht Basin Dr.
- The commissioners deferred that this go on the January 2026 meeting (or February if it doesn't happen) for further discussion.
- PIE discussed as an organization that part of our responsibility is to provide information to the public, including the implications of the location.
 - Is it a non-profit, a for-profit?
 - Is it running 24 hours, what the noise implications
